Today's speaker is Tom Nelson. Tom is a former law enforcement officer and retired as a Lieutenant and regional supervisor for the Minnesota State Patrol Commercial Vehicle Section's St. Cloud/Brainerd Region. Tom spent 34-years in law enforcement and 31 of them with the Minnesota State Patrol.

During his tenure with the Patrol's Commercial Vehicle Section, in addition to his supervisory duties, Tom served as the Civil Weight Program Coordinator and Mandatory Inspection Program Coordinator. Tom was responsible for the organization of a joint agency oversize/overdimentional load permit group consisting of personnel from the Minnesota State Patrol and the Minnesota Department of Transportation. Tom served as the Patrol's liaison to the Minnesota Department of Transportation regarding all of the permanent scales sites located throughout Minnesota and oversaw and reported the results of a Weigh In Motion (WIM) portable scale project that was developed to determine the feasibility and effectiveness of utilizing portable WIM scales during enforcement projects. Tom was also responsible for the rulemaking process and implementation of Minnesota's Pilot Escort Driver and Vehicle training and certification program.

Since June, 2017, Tom has served as the Coordinator for the Truck Weight Education Program funded by the Minnesota Department of Transportation and administered by the University of Minnesota's Center for Transportation Studies.

Tom has a passion for commercial vehicle regulation education and has served, and continues to serve, as a keynote speaker and guest speaker, giving several

presentations to multiple businesses, organizations, and associations related to the motor carrier industry.
